- 5. Kansetsu waza allowed in all advanced senior divisions regardless of age. (min. age for Sr. div. is 15) No Shime waza nor Kansetsu waza in novice senior divisions
- 6. If your name is called first you must wear a white gi. Second called may wear either a blue or white gi with blue belt. If blue gi is used both contestants should wear their regular rank belts.
- 7. Must be in judo gi to receive your medal
- 8. Must have your own white & blue belts
- 9. Must have footwear on when you are off the Mat

### ARNOLD CLASSIC BOC 2023 JUDO SHIAI WARNING! WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, the Arnold BOC 2023 Judo Shiai and related events and activities of USA Judo, USJA, USJF, ATJA, Ohio Judo Inc., Arnold Classic, Oriental Martial Arts College, and The Ohio Expo Center, I hereby:

- 1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
- Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official or such condition(s) and refuse to participate.
- 3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death. Traumatic Brain Injury (TBI), and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the action, inaction or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
- 4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability or death.
- 5. Release, waive and discharge and covenant not to sue the USA Judo, USJA, USJF, ATJA, Ohio Judo, Inc., Arnold Classic, Arnold Classic BOC, Oriental Martial Arts College, and The Ohio Expo Center, together with their affiliated clubs, their respective administrators, directors, agents, coaches, and other employees or volunteers of the organization, sponsoring agencies, sponsors, advertisers, and, if applicable, owners, lessors, and lessees of premises used to conduct the event, all of whom are hereafter referred to as "releasee", from any and all claims, demands, losses, or damages on account of injury, including permanent disability or death or damage to property, caused or alleged to be caused in whole or in part by the negligence of the releasee or otherwise to the fullest extent permitted by law.
